PRODUCT: Peach Compote

ITEM NUMBER: 93140

DESCRIPTION: Frozen fruit based compote. Peaches are diced and mixed with slightly thickened, sweetened syrup.

Packed in 1 gallon pail and frozen to maximize product quality.

INGREDIENTS: Peaches, Cane Sugar, Water, Corn Starch, Citric Acid, Natural Flavor, Fruit and Vegetable Juice (for

Color).

RAW MATERIAL: IQF Peaches, prepared from ripened fruit that is freshly harvested. Fruit will be washed, sorted, drained,

peeled, pitted, sliced, and individually quick frozen. Flavor will be typical of peaches, with no off-flavor

or aroma.

PROCESSING: Prior to dicing, fruit is washed in Tsunami® 200, a proprietary antimicrobial agent. Product is not

pasteurized.

Color: Yellow-Orange, typical color of peach pieces in syrup.

Flavor: Typical of ripe peaches in heavy syrup.
