PRODUCT: Tangerine Smooth Pourable Fruit

ITEM NUMBER: 91306

DESCRIPTION: Tangerine puree is mixed with a thickened, sweetened sauce and pasteurized. Tangerine Smooth is packed in 32 fl oz net volume plastic bottles and frozen to maximize product

INGREDIENTS: Tangerine Puree ([Tangerine Juice Concentrate, Water, Pulp Cells, Citric Acid, Tangerine Oil], Water), Cane Sugar, Less than 1% of the following: Citric Acid, Guar Gum, Xanthan Gum.

PROCESSING: Product is pasteurized following FDA guidelines for Juice HACCP: 21 CFR part 120.

PHYSICAL PROPERTIES:

Brix: 32.0° – 36.0°
pH: 2.60 – 3.20
Piece Size: Pourable and smooth.
Viscosity: 10 - 18 cm/10 sec. (Bostwick at 40 - 50°F).
Color: Light Orange color, typical of Tangerine.
Flavor: Typical of ripe, sweetened Citrus.

METAL DETECTION:

During production, inline metal detectors are challenged and calibrated hourly for adequate sensitivity to and rejection of the following test pieces:

- Ferrous 1.0mm
- Non-Ferrous 1.5mm
- Stainless Steel 2.0mm

PACKAGING: High density polyethylene (HDPE) bottles with induction seals and polypropylene (PP) lids, 6 bottles per corrugated case. Production lot number, time of fill and best used by date are printed on the bottle. Item number, production lot number and best used by date are printed on the case label.

LOT CODE FORMAT:

Identifies the date of production and final four digits indicate the time of processing in 24-hour format [military time]

YYMMDD ##### YY = Year MM = Month DD = Day ##### = Military time

Example: 240711 1643 = July 11, 2024 at 4:43 pm

Production lot number, time of fill, and best used by date are printed on the bottle.

Product code and production lot number are printed on the case label.

Kosher (OU), Vegetarian, Vegan, Product of USA, made from domestic fruit.

BEST USED BY:

30 months when stored frozen in original unopened containers.

Use within 30 days after removal from frozen storage.

STORAGE:

Store and ship frozen at or below 0°F (-18°C). To use, thaw refrigerated 12 – 24 hours.

Refrigerate after opening and use within 30 days after removal from frozen storage.
