General Use Directions

NOTE: For initial cleaning and optimum surface protection and performance of the wipes, it is recommended to use the wipes and if needed, a Scotch-Brite™ scouring pad to remove any burnt-on grease and stubborn soil.

- 1. Clean the surface with a fresh wipe. If needed, use a dry towel to remove any excess residue from the surface.
- 2. Repeat as necessary until the grease is removed and the surface is clean.
- 3. Dispose of used wipes in trash. Do not reuse wipes.
- 4. Repeat steps 1-3 regularly for best results.

Scotch-Brite™ Kitchen Cleaner & Degreaser Wipes with Scotchgard™ Protector can be stored at normal room temperature. Reseal the peel back lid securely to prevent wipes from drying out during storage.
