1. Tests T.1 toT.5 are conducted in sequence on the same battery. Tests 6 and 8 are conducted using not otherwise tested batteries. Test T.7 may be conducted using undamaged batteries previously used in Tests T.1toT.5 for purposes of testing on cycled batteries.
