TERMS & CONDITIONS

FOH, Front of the House, and room360 products are available through authorized dealers only. Please contact us to locate a dealer in your area.

All purchase orders must be submitted in writing by email or fax.

Purchase orders must be placed in case pack quantities.

Purchase orders with errors or incomplete information will not be processed and will be returned to the Dealer for revision.

Dealer is solely responsible for the accuracy of the submitted Purchase Order. FOH reserves the right to reject any requested Purchase Order changes or price adjustments on orders already shipped and invoiced.

All special and custom orders require 100% prepayment prior to production.

Prices are subject to change without notice.

FOH holds intellectual property rights, including but not limited to trademarks, copyrights, design patents, and utility patents on our products, and will use any and all means to enforce these rights.

All orders are shipped Ex Works (EXW) from an authorized FOH Distribution Center.

All freight quotes are valid for 10 days. Freight quotes may be subject to fuel surcharges.

Please examine your order upon arrival for any discrepancies. Claims must be reported to Customer Service within ten (10) days of receipt.

Any damage or loss must be claimed by the consignee with carrier.

Upon receipt of shipment, and before signing BOL, please ensure that FOH security tape and shrink wrap are intact. Any damage or shortage must be noted on the delivery ticket at the time of delivery and must be reported to the carrier and our Customer Service Department within 48 hours.

Customers are solely responsible for original freight costs as well as any additional shipping fees involved with their order. If Inside Delivery, Arrival Notification & Lift Gate Service is provided, an additional shipping invoice will be created and sent at a later time.

Orders shipped via pallet will incur a charge per pallet. Pallet fees are subject to the final destination. Pallet fees are subject to change without notification.

VAT included on quotations, proforma invoices, and sales orders are estimates only. Final VAT will be calculated on the final invoice.

For intra-community VAT-exempt sales, customers are required to communicate to FOH both their VAT number and a copy of their VAT Exemption Certificate.

Customers are solely responsible for payment of applicable sales taxes import VAT fees, brokerage fees, duties, and taxes incurred with their order.

To request credit terms, customer must submit signed FOH credit application. Terms are extended at FOH's discretion. Failure to adhere to terms may result in revocation of credit terms and account will move to prepaid status.

Credit terms will be revoked on delinquent accounts. FOH will not ship to accounts with a past due balance; these accounts will be placed on credit hold until payment is received. In addition, any reserved product(s) will be returned to open inventory.

Invoice deductions must be authorized by our Accounting Department within 10 days from invoice date. Non-qualifying deductions will result in a \$75 administrative fee payable upon receipt.

Customers approved for our early payment discount program must comply with the terms of the agreement. Early payment discounts only apply to payments made and received within 10 days of invoice date. This incentive may be revoked at FOH's discretion at any time. Any non-qualified deductions will be considered non-compliance.

Customer agrees to pay all collection costs and attorney fees, as well as interest at the rate of 1.5% per month on any unpaid balance.

A \$35 fee will be charged for any returned checks.

All check or credit card payments must be made in US Dollars. Wire payments may be made in US Dollars, Euro, or GBP currencies; customers shall pay for all outgoing wire fees and currency conversions.

No returns will be accepted without FOH return authorization (RA) number and must be received in salable condition and in its original packaging at the address specified on the RA.

Customers returning merchandise will be charged a 20% restocking fee and all return freight charges.

All cancellations must be received in writing, have prior authorization, and a confirmation number issued by FOH.
