Understandably, sometimes buyers need to be educated on the evolving environment.

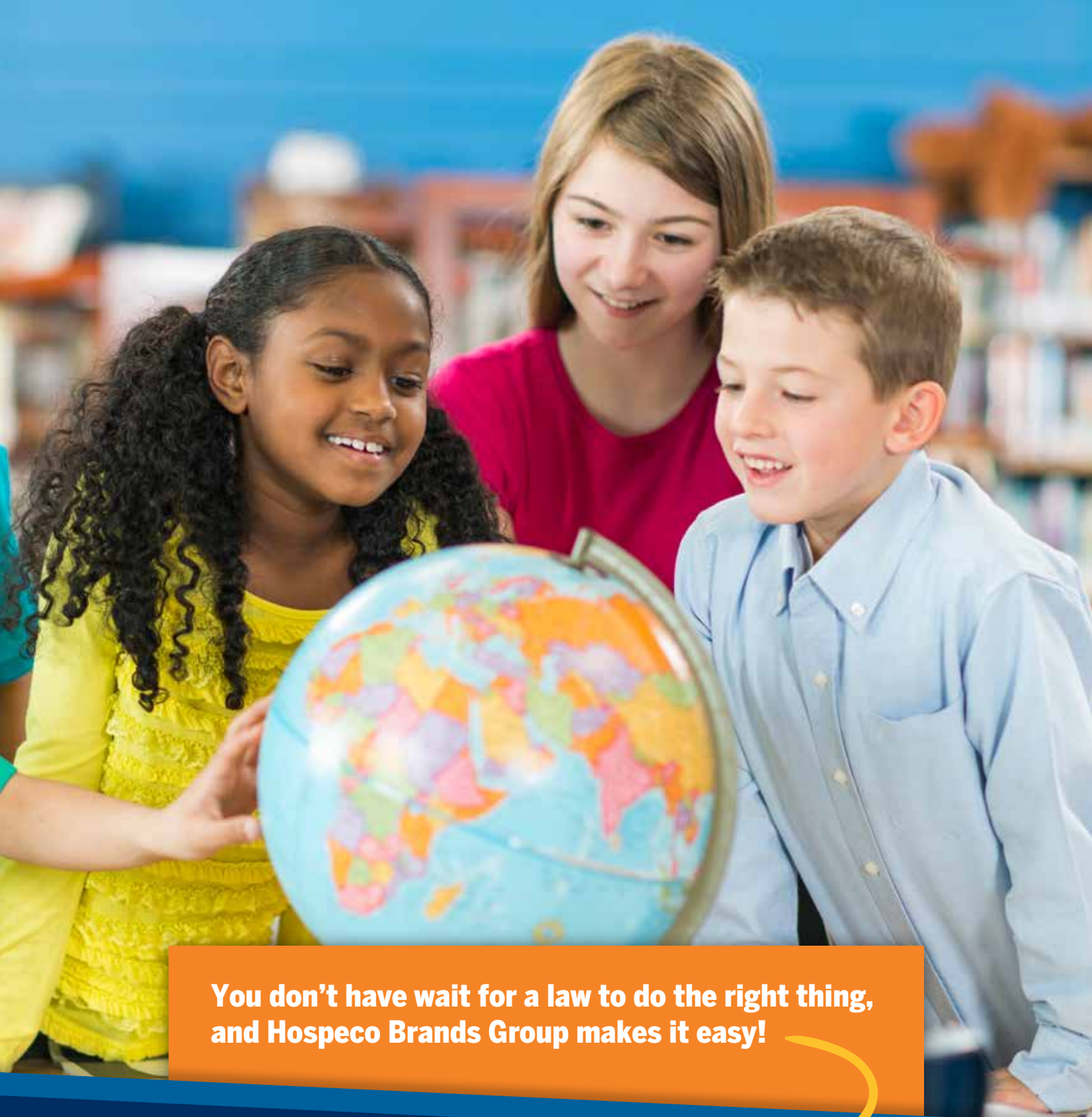

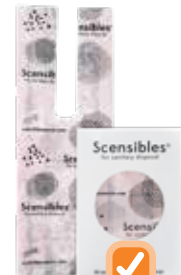
