General description of audited organization	 The activities are carried out in two separate buildings: Site A - via Lombardia 44: Head office, main production plant Site B - via Lombardia 19: secondary production plant, warehouse of ambient stable products and packaging. The plant at via Lombardia 19 produces gluten-free powder mixes for bakery (for cakes, buns, pizzas, etc.) and packaging of flours (own brand and third parties) also from organic farming - powder mixes and packaging of flours (gluten free). It also serves as a support for main site located at via Lombardia 44: completion of the packaging of powders, storage of the finished product, environment and packaging. The plant was leased in 2015, initially born only as warehouses, then the mixing line for powder and flour preparations was added (completed in 2021). The total area is 1500 square meters of which about 1000 for the warehouse and 68 for the mixing and packaging room. Products: mixing and packing of bakery powder/flours.
