The U.S. FDA does not have compliance standards for napkins related to indirect food contact since it does not consider paper napkins or similar products subject to the Food, Drug, and Cosmetic Act when they are sold only for conventional wiping purposes. However, the Hoffmaster Group Inc. product(s) meet FDA CPG Sec 100.600 and are deemed safe for use as directed.

With the exception of the products listed in Annex 1, Hoffmaster Group, Inc. does not intentionally add fluorinated chemistries into our products, as defined as a class of fluorinated organic chemicals containing at least one fully fluorinated carbon atom though not exclusive, these forever chemicals are commonly referred to as perfluoroalkyl and polyfluoroalkyl substances, or PFCs/PFAS chemicals. Included in the list are Perfluorooctanoic acid (PFOA), Perfluorooctane sulfonic acid (PFOS), and polyfluorinated chemicals (PFC). In addition, Hoffmaster is actively working to modify our portfolio to replace all products listed in Annex I with suitable alternatives that do not contain fluorine chemistry as defined above. This information is based on our knowledge at the time of signing. It is the responsibility of the user to assess their final product to ensure its compliance with any applicable regulations.
