



## **CHASE INDUSTRIES INC.**

### **LIMITED WARRANTY**

### **DURULITE STANDARD DOORS**

1. Chase Industries, manufactures Durulite **Standard Doors**. Chase Industries warrants that the doors and all related parts shall be free from defects in workmanship and material, under normal use, for a period of seven hundred thirty (730) days from the date of installation, or seven hundred sixty (760) days from the date of shipment, whichever shall occur first. Any part manufactured by Chase Industries which is proven defective as to material or workmanship within 760 days from the date of shipment by Chase Industries will be replaced free of charge F.O.B. Redmond, Oregon, upon the return of such defective parts to Chase Industries properly crated, transportation prepaid. No parts, however, shall be returned without the express written authority of Chase Industries. Chase Industries makes no warranties, express or implied, except such warranties as are definitely set forth herein. This warranty is void if the equipment is used in a manner not in conformity with Chase Industries published installation instructions. Misuse, accident, alteration, improper installation, act of God, or abuse of equipment shall void the warranty.
- 2 THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION OF THE FACE HEREOF. CHASE INDUSTRIES MAKES NO WARRANTY OF MERCHANTABILITY OR IMPLIED WARRANTY OF FITNESS AS TO ITS PRODUCTS.
- 3 CHASE INDUSTRIES LIABILITY UNDER THIS WARRANTY SHALL BE LIMITED TO REPLACEMENT, AND UNDER NO CIRCUMSTANCES SHALL CHASE INDUSTRIES BE HELD RESPONSIBLE FOR ANY CONSEQUENTIAL OR OTHER DAMAGES, LOSSES, OR EXPENSES WHICH MAY ARISE FROM THE INSTALLATION OR USE OF THE EQUIPMENT, REGARDLESS OF ADVICE OR RECOMMENDATIONS THAT MAY HAVE BEEN MADE BY ANY AGENT OR EMPLOYEE OF CHASE INDUSTRIES OR ITS DISTRIBUTORS/DEALERS.
- 4 The distributor and/or dealer is not authorized to make any warranty of performance or efficiency or other operating guarantee on any Chase Industries product for any of its component parts not set forth herein. The seller's salesman may have made oral statements about the merchandise described in this contract. Such statements do not constitute warranties, shall not be relied upon by the buyer, and are not part of the contract of sale. The entire contract is embodied in this writing. This writing constitutes the final expression of the parties' agreement, and it is a complete and explicit statement of the terms of that agreement.

#### **MATERIAL SHIPPING UNDERSTANDING**

- 5 Chase Industries shall not be responsible for any delay in shipping resulting from destruction of offices, warehouses, factories, or other facilities, strikes, lockouts, shortage of merchandise at the factory or plant of Chase Industries, delays in obtaining merchandise from a factory or plant or other sources of supply, act of God, or other causes.

#### **RESERVATIONS AND RIGHTS FOR IMPROVEMENTS**

- 6 Chase Industries reserves the right to make changes in design or improvements upon its products without assuming any obligation to change products therefore manufactured in the same manner.

#### **APPLICATION CONDITIONS**

7. Where standard doors are subject to forklift or manridden carrier traffic, this warranty shall be VOID. All Durulite doors for openings eighty-four (84) inches or wider must be installed with bollards, limiting posts or door steps in order for this warranty to be valid. These items will prevent the door panel from travelling beyond the point for which it was designed.

#### **RIGHTS TO REQUIRE OPTIONS**

8. Chase Industries reserves the right to require certain options or accessories on specific installations in order for the two (2) year warranty to be in effect.
