15 YEAR ORIGINAL EQUIPMENT PANEL WARRANTY - RSG FOAM WALK-IN ROOM PANELS

WARRANTY COVERAGE: This warranty neither assumes, nor authorizes any person to assume, any obligation other than that covered by this warranty, and applies only within the continental boundaries of the United States of America, its territories and possessions, and Canada.

Master-Bilt Products, LLC or Norlake, Incorporated, as applicable (the applicable entity, "RSG"), warrants this product to be free from defects in material or workmanship under normal use and service. In the event of failure, the obligation of RSG under this warranty shall be limited to repairing or replacing with a like panel, at RSG's option, F.O.B. Hudson, WI, any original equipment panel of the warranted original equipment product which proves defective, and which RSG's examination shall disclose to its satisfaction to be thus defective, and which cannot be placed back into operation in the field with normal service efforts.

RSG warrants this product to be free from defects in material or workmanship under normal use and service. In the event of failure, the obligation of RSG under this warranty shall be limited to replacement materials.

A replacement panel installed as a result of this warranty is not subsequently covered by this warranty. RSG reserves the right to require the return, collect freight, of any defective panel. An RSG provided authorization number is required before the return of any panel.

The warranty is in force for fifteen (15) years from date of installation, but not longer than fifteen (15) years, three (3) months from RSG invoice date. Any claim for defects occurring between fifteen (15) years and fifteen (15) years, three (3) months from RSG invoice date must furnish proof that installation date did occur within three (3) months of RSG invoice date.
