

LIMITED WARRANTY



1 YEAR WARRANTY

Your Novo by Noble Chemical Automatic Soap Dispenser is warranted to be free from all defects in material and workmanship in normal use **for a period of one year** effective from the **date of purchase** of the equipment. The warranty is granted only to the original purchase of the automatic soap dispenser. The warranty is subject to the following provisions.

WHAT THIS WARRANTY DOES NOT COVER:

Novo by Noble Chemical will not warrant coverage for product failure or damages that arise under the following conditions:

- Damages or malfunctions caused by negligence, abuse, improper use, or actions not in accordance with the User Manual.
- Damage or failure due to improper utility connection or supply, and issues resulting from improper ventilation or airflow.
- Equipment sold or used outside of the Continental United States
- Equipment used for residential or other non-commercial purposes.
- Defects or damages caused by improper maintenance, use of any replacement parts other than Novo by Noble Chemical original parts, wear and tear, misuse, abuse, vandalism, or Act of God.

Novo by Noble Chemical will, at its option, repair or replace a defective automatic soap dispenser that is covered by this warranty. As a matter of warranty policy, Novo by Noble Chemical will not refund the consumer's purchase price.

Novo by Noble Chemical does not recognize third-party sales; the warranty is null and void if the unit is purchased from any non-authorized dealer.

The seller shall in no event be liable for direct, indirect, or consequential damages in connection with Novo by Noble Chemical products.
