PestWest USA, L.L.C.(PestWest) warrants this product, exclusive of the lamps and starters, against defects in materials or workmanship for a period of three (3) years after the date of shipment to the original purchaser. In the event of a valid claim against the warranty, PestWest shall, at its own cost and in its sole discretion, repair or replace a defective item or product or return the purchase price therefore to the proper claimant. All other warranties, express or implied, are expressly disclaimed, including, but not limited to warranties of fitness or merchantability. To the fullest extent permitted by law, PestWest limits the sole and exclusive remedy of all claimants for losses or damages to the value of the cost of repair or replacement of any defective goods and excludes all actual damages in excess of such value and all consequential or exemplary damages, including but not limited to claims for personal injury or suffering, lost profit, loss of production, property damage, special damages, or similar personal or economic loss claimed by or through an injured party irrespective whether such losses were foreseeable or discussed by the purchaser with the vendor of the goods.

You must follow the following procedure to make a valid claim under this warranty:

YOUR RESPONSIBILITY:

1. Owner's manual and warranty registration. You should read the owner's manual thoroughly before installing, using or operating this product. You should also make sure that your name and address are on file as owners of a PestWest product by completing and mailing the enclosed registration card within ten (10) days after the original purchase of the product. This allows PestWest to establish the date of your purchase of our product as well as to provide you with new product information. (Failure to return the card may not affect your rights under this warranty so long as you retain other acceptable proof of purchase such as a shipping invoice or bill of sale).
2. You must retain your bill of sale or provide other proof suitable to PestWest of purchase and date of purchase.
3. You must notify PestWest or our authorized service station in writing within thirty (30) days after you discover a defective product or part, following company procedures and instructions then in effect.
4. Upon receipt of PestWest's Return Goods Authorization (RGA) number, you must deliver the entire product to PestWest or its authorized service center and you must pay for all transportation and insurance charges for the product to PestWest.
5. All warranty servicing of our product must be made by PestWest or a PestWest authorized service center. Call 866.IPM.PEST (476.7378) for details.

The claim under this warranty may be validated only upon proof of purchase that the product was purchased from an approved distributor. This warranty covers only defects in materials or workmanship as limited above and does not extend to damage to products or parts caused by misuse, accident, transportation mishandling, improper installation, use, or maintenance in violation of the instructions in the manual supplied with the unit or to a unit which has been modified or with defaced serial numbers or operated with unauthorized replacement parts. **This warranty does not cover replacement of bulbs, glue boards, lamps, or lamp starters. For replacement components, contact your favorite authorized PestWest distributor. Use only original PestWest branded components. Use of non-PestWest branded or unauthorized replacement components, voids this warranty in it's entirety.**
