Warranty

Shop-Vac USA, LLC ("Shop-Vac®") warrants to the original purchaser that the Shop-Vac® vacuum cleaner ("Product") when used for normal household use in accordance with the User Manual, will be free from defects in material and workmanship. The warranty begins on the date of purchase and ends when the Product becomes unusable for reasons other than defects in workmanship or material.

Remedies

Shop-Vac® will, as the sole and exclusive remedy available for warranty breach, replace defective parts or the entire Product as determined by Shop-Vac® in its sole discretion.

What is not covered by this warranty?

- 1. Accessories and filters.
- 2. Any Product that has been tampered with or used for commercial purposes.
- 3. Defects caused by use of non-genuine Shop-Vac® filters and/or accessories.
- 4. Damage or faulty performance caused by misuse, careless handling, normal wear and tear.
- 5. Defects caused by repair persons not authorized by Shop-Vac® including damages caused in the shipping, altering, or repairing of the Product (or any of its parts) when not authorized by Shop-Vac®.
- 6. Products purchased, used, or operated outside of the United States or Canada.
