VacPak-It and Ready Kitchen Warranty reserve the right to approve or deny the repair or replacement of any part or repair request. The warranty is not transferable. VacPak-It equipment installed in/on a food truck or trailer will be limited to a period of 30 days from the original date of purchase.
