## 2. HAZARD IDENTIFICATION

## 6. ACCIDENTAL RELEASE MEASURES

- 6.1** Spills:  
Before cleaning any spill or leak, individuals involved in spill cleanup must wear appropriate Personal Protective Equipment. 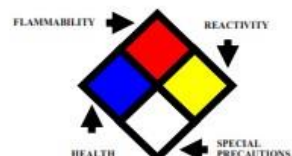
