## INSTALLATION TIPS

Use 1/4" water line

Flush IN-10 CC by running water through filter for three minutes at full flow

## OPERATION TIPS

Change cartridges on a regular 6 month preventative maintenance program

Change cartridges when capacity is reached or when pressure falls below 10 psi

Service flow rate must not exceed 1 gpm

Always flush the filter cartridge at time of installation and cartridge change

## APPLICATION/SIZING

For low volume, espresso applications with flow rates up to 1 gpm

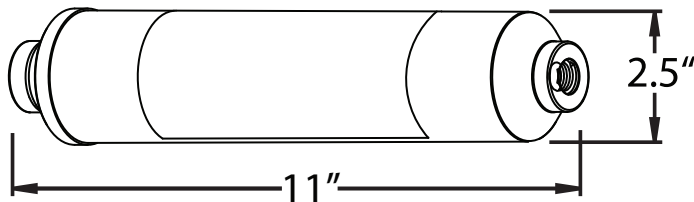
