Change cartridges on a regular six (6) month preventative maintenance program.

Change cartridges when capacity is reached or when pressure decreases.

Allow 2 ¹/₂" (6.4 cm) clearance below the cartridge for easy cartridge replacement.


Mounts directly onto flat surface. Install

vertically so cartridge hangs down.

Flush filter by running water through filter according to cartridge instructions.
