- Ingredients: Imported Pecorino Romano: (Pasteurized Sheep's Milk, Cheese Cultures, Salt, Enzymes), Romano Style Cheese: (Corn Starch, Water, Palm Oil, Cellulose, Salt, Natural Flavor, Caseinate, Sorbic Acid (as a preservative)), Powdered Cellulose added to prevent caking, Natamycin (A Natural Mold Inhibitor).

  - **IX. Storage/Shipping:** Product may be stored/ shipped in temperatures between 33-55 degrees Fahrenheit for periods NOT TO EXCEED 72 hours.
